## A NOTE TO ALL DONORS

If you designate your contribution, funds may not be designated to: agencies without verifiable Internal Revenue Code Section 501(c)(3) non-profit status, religious institutions, those that exist solely for political purposes, or those that practice unlawful discrimination. Designations not meeting these criteria will be automatically redirected to Community Care. United Way fundraising and administrative costs are 21%. IRS regulations strictly dictate that donated funds may not be used to pay a pre-existing legally binding pledge, or for anything providing a direct benefit to the donor. This form alone is not sufficient IRS documentation.

A year-end pay stub or employer-issued W-2 is also required.
